RE: VOTERS WANT UPDATED AIR TRAFFIC CONTROL SYSTEM IN U.S. DATE:

SEPTEMBER 19, 2025

In a recent survey of registered voters (see methodology statement on last page), Fabrizio, Lee & Associates probed American voters' opinions on the state of the air traffic control (ATC) system. The data shows that American voters are overwhelmingly concerned about the current state of the system and support updating our air traffic control system. American voters want the federal government to take a new approach by partnering with a company unburdened by historical baggage and focused on safety in this new, transformative project.

The Air Traffic Control System is Not Working

When asked what one or two things comes to mind about the current state of America's air traffic control system, respondents indicated concerns over airplane crashes and accidents and antiquated equipment. Secondly, there is strong agreement that America's ATC is falling behind others in terms of modernization (59/18) as compared to other countries' systems. We also found that the American public today is split on if government is doing enough to ensure air traffic at major U.S. Airports is safe (44/44) and whether our current ATC system is safe and reliable (47/43).

Americans Support Fixing the System

Americans support President Trump's announcement to modernize the air traffic control system, 71% - 19%. When informed about specific funding details delivered by President Trump's Working Families Tax Cut, American voters support overhauling the approach by an even higher mark, 81% - 14%. Delivering on modernizing the air traffic control system is a priority of the American people.

Priorities for a federal contractor working on modernizing the air traffic control system reflect a desire for a responsible, American company with a proven but unbiased history. American voters indicated that prioritizing safety (88% important), having a history of training and retaining American workers (86%), being unconflicted (83%), bringing no historical baggage of providing failed technology (81%), and possessing a proven track record with key stakeholders (78%) are the most important characteristics they are looking for in choosing a federal contractor to work on this project.

To upgrade the US Air Traffic Control system, the Trump Administration will have to pick a private company that will do the work to upgrade the system. Bottom Line: American voters are distressed about the state of the Air Traffic Control system. They also overwhelmingly approve of President Trump's plan to invest in its modernization. To enact this needed change, the people want a federal contractor that prioritizes safety, hires and trains American workers, is unconflicted, does not bring any baggage, and is experienced. A

private company that fits those descriptions would be a very popular choice among American voters to deliver one of the most popular aspects of President Trump's Working Family Tax Cut.

<u>METHODOLOGY STATEMENT</u>: Fabrizio, Lee & Associates conducted a survey of 1000 National Registered Voters from September 15-17, 2025. The interviews were split 35% live-operator cell phone/25% live-operator landline/40% SMS to web. Geography was matched to registered voter statistics. Gender, age, race/ethnicity, party, and education were matched to demographic profiles of registered voters based on the voter file and census data of registered voters. Respondents were randomly selected from lists of registered voters. The margin of sampling error for 1000 registered voters at the 95% confidence interval is ±3.1%.
